There are three main systems of government used today: unitary systems, federal systems, and confederate systems. A unitary system has the highest degree of centralization. In a unitary state, the central government holds all the power.

A republic is a form of government in which the citizens elect representatives, who make all of the decisions for them. This is different from a democracy, in which the people make their own decisions on important issues by voting. This form of government does not have a monarch, but an elected leader. The first republic may have originated in Carthage, North Africa.
