State solar rebate program: Maryland is one of the few states that have a statewide solar rebate. It's called the Residential Clean Energy Rebate Program, and it provides a cash-back incentive of \$1,000 for systems over 1 kW, which includes virtually all residential solar systems. 33 There's also a \$500 rebate for solar water heaters.

On June 25, 2019, Governor Larry Hogan signed Executive Order 01.01.2019.08, which applies to State-owned buildings. The E.O. calls for a 10% reduction in energy consumption by 2029 compared to a 2018 baseline. While its overall mission is to promote clean, affordable, and reliable energy for the benefit of all Marylanders, MEA is also a resource for State agencies ...

Some Maryland utilities are offering rebates on EV charging equipment. These utility rebates can be combined with the Maryland Energy Administration's Electrical Vehicle Supply Equipment (EVSE) rebate. EV drivers in Baltimore Gas and Electric (BGE), Pepco, or Delmarva Power utility service territories may be eligible for a \$300 rebate.

All state solar tax credits can be claimed in addition to the federal government's investment tax credit. They vary in amount, but are usually a percentage of the total cost of the system. Maryland State Incentives The Maryland Residential Clean Energy Grant program, offered by the Maryland Energy Administration, provides incentives for eligible homeowners who purchase solar energy systems for their primary residence. (These incentives are not available to homeowners who sign a lease or power purchase agreement.)

The Maryland Energy Administration runs the Residential Clean Energy Rebate Program. The initiative offers a flat \$1,000 grant for residential solar photovoltaic systems of at least 1 kW in size.

The Maryland Residential Clean Energy Rebate Program offers rebates to homeowners who install solar energy systems. Eligible homeowners can get a rebate of up to \$1,000 for solar panel installations. To be eligible, your system needs to be at least 1 kW.

The following clean energy systems are eligible for Residential Clean Energy Rebates. Systems must fall within the Eligible System Capacity Range to qualify for rebate consideration.

What is the Cost of Solar Power in Maryland? It's difficult to pin down an exact cost of solar panels in Maryland, but the average cost of a MD solar panel installation is between \$12,000 and \$17,000, or about \$2.75 to \$3.05 per watt, after considering federal tax credits. The nationwide average is slightly higher, averaging approximately \$2.50 to \$3.50 per watt.

The federal solar tax credit (part of the Residential Renewable Energy Tax Credit) that offers 30% off your home solar installation is dropping at the end of 2019. All homeowners who install a solar panel system by the end of 2019 can still claim the full 30% credit, but that amount drops to 26% in 2020.
