In Australia, the Government incentives you to switch to commercial solar with Business Solar Rebates that allow your business to generate Renewable Energy Certificates (RECs). These certificates can be sold to energy producers, who use them to meet their Government-mandated carbon targets.

You can save money on a rooftop solar system for your home or business through a range of government assistance schemes. There are also some schemes to help with the cost of a battery. The Australian Government's Small-scale Renewable Energy Scheme (SRES) reduces the cost of most new residential and business rooftop solar systems.

At the time of writing (October 2024), ENGIE, Globird Energy, ActewAGL currently have the highest solar feed-in tariff offer in NSW, whereby the maximum a customer can get is 12 cents per kilowatt hour (c/kWh).
