DC Solar founder and owner Jeff Carpoff was sentenced to 30 years in prison on Tuesday for masterminding a billion-dollar Ponzi scheme. Carpoff had previously pled guilty to conspiracy to commit wire fraud and ...

At about 9:30 a.m., the agents swarmed DC Solar headquarters, while a SWAT team broke down the front door of the Carpoffs" hillside home. Agents found nearly \$1.7 million in cash in Carpoff's office safe. The agents pressed employees for the location of his cars. They were pointed down the street, to a trio of pristinely maintained warehouses.

DC Solar Solutions Inc. and DC Solar Distribution Inc. were founded by Carpoff in 2009 to manufacture, sell and lease mobile solar generators, or MSGs, that provide emergency power to cell towers and lighting for sporting events. The company and its entities sold the MSGs to investors for \$150,000 each through specially created tax-equity funds.

Alan Hansen, 50, of Vacaville, a former employee of a telecom company with which DC Solar purported to do business, pleaded guilty on July 28, 2020, to participating in the fraud scheme and accepting a \$1 million bribe to sign a false contract. Karmann, Guidry, and Hansen are scheduled to be sentenced on Dec. 14, 2021. ...

DC Solar Solutions, a sponsor of Chip Ganassi Racing's NASCAR program and sponsor of several NASCAR Xfinity Series races in 2018, was raided by the FBI right before Christmas.

The company was founded in 2008 in Concord, California, by Jeffrey Carpoff, an auto mechanic. Berkshire Hathaway invested \$340 million in the company. The company supplied solar panels, named Solar Eclipse, to various higher education facilities (using a subsidiary, DC Solar Freedom, for education-related partnerships) such as California State University and Long Beach City College and various NASCAR tracks; it also sponsored Chip Ganassi Racing and several races in the N...

On Nov. 16, 2021, Joseph W. Jeff Carpoff was an owner of DC Solar. The California-based company leased solar powered generators. But, behind the scenes, a larger scheme was in play to fund a luxurious life. ... After a raid of DC Solar in December 2018, Chip Ganassi was forced to close down his Xfinity Series operation due to a lack of sponsorship.

For top-of-the-line solar panels, most homeowners invest between \$20,000 and \$60,000 before accounting for tax credits and other incentives.. On average, Washington DC solar panels cost about \$34,000 and cover about 83% of electricity costs.
