According to the USPS website, you CAN ship a cell phone with a lithium-ion battery already installed. However, there are limits on the battery's Watt-hour (Wh ...

Each lithium-ion or lithium polymer cell or battery must not exceed a watt-hour rating of 2.7 Wh. Note: Shipments containing lithium batteries are not permitted in Global Express Guaranteed ...

For shipping lithium batteries with USPS overseas, you can ship a maximum of 4 cells or 2 batteries that are installed in the new or certified refurbished equipment or device it operates, without any lithium battery markings. However, individual batteries are prohibited from USPS international shipping.

Except for mailpieces containing button cell batteries properly installed in the equipment they are intended to operate, mailpieces containing mailable lithium metal or lithium-ion batteries must be rigid, sealed, and of adequate size, so the lithium battery mark can be affixed to the address side without the mark being folded.

Also, while I was just at the post office, I asked about the air-shipping restrictions for items with batteries, and I specifically asked if it was just for Lithium-ion batteries, and she said that this restriction applies for any type of battery.

Except in limited circumstances, pets and warm-blooded animals may not go in the mail. Shipments of live animals, including poultry, reptiles, and bees, have very specific packaging ...

Lithium batteries are dangerous goods, and all of the regulatory requirements must be complied with, as set out in the Lithium Battery Shipping Regulations. In the United States, failure to comply with these regulations can result in a civil penalty of up to \$27,000 per offence (LBSR 1.3).

Persons wishing to ship lithium batteries and electronic devices containing lithium batteries should be aware that certain requirements must be met to ensure safety. PHMSA and the U.S. Postal Service collaborated on a set of safety guidelines for those wanting to ...

If your laptop has a lithium battery, you have to use a special label that indicates that your package contains lithium batteries. You can get this label from a postal store or online. The label should have the words "Lithium Battery" and "UN 3481" on it, ...
