As used in this section, consignment means one or more packages of hazardous materials accepted by an operator from one shipper at one time and at one address, receipted for in one lot and moving to one consignee at one destination address. Equipment means the device or apparatus for which the lithium cells or batteries will ...

If you're shipping lithium metal batteries contained in or packed with equipment, use a battery label with UN3091.
