Lithium Metal Batteries in compliance with Section II of PI968 are FORBIDDEN in DHL Time Definite International AWB nr: Shipper: I hereby declare that the shipment containing bellow mentioned Lithium Batteries is compliant with the ICAO / IATA DGR

Lithium cells or batteries that fit within these limits are subject to Section II of the applicable lithium battery packing instructions in the DGR. Each package that contains such cells or batteries, including those installed in devices, must not contain more than 5 kg net weight of lithium cells or batteries.

Each such package must bear the lithium battery mark and when an air waybill is used the air waybill must show the applicable compliance statement, e.g. "lithium ion batteries in compliance with section II of PI 967".

Note 4: Lithium batteries packed according to PI968 Section IA and PI969 & PI970 Section I are not accepted in Time Definite International when transported via road to/from an ADR member state. PI968 Section IA / IBand PI969 & PI970 Section I - Cells and batteries must not be packed in the same outer packaging, or placed in an overpack with ...

-- Where a consignment includes packages bearing the lithium battery mark, the words "lithium metal batteries, in compliance with Section II of PI970" must be placed on the air waybill, when ...

Yes. The mark may bear all applicable UN numbers, e.g. UN 3091, UN 3481, to identify that the package contains lithium metal batteries packed with or contained in equipment and lithium ion batteries packed with, or contained in equipment.

PI967/PI970 section II - Lithium Ion/Metal Batteries contained in Equipment (no more than 4 cells or 2

batteries) = Lithium label exempted. Electronic equipment with lithium batteries (under ...

ACCEPTABLE with conditions! Electronic equipment with lithium batteries (under PI967/970 section II less than 4cells/2 batteries) fully integrated into the equipment. Non-removable by user. ACCEPTABLE with conditions! Prior Approval needed. STRICTLY FORBIDDEN ! Loose or standalone batteries (regardless of quantity, high or lower power).

Example: Lithium metal batteries in compliance with Section II of PI969. Step 2) Information on a Separate Document (see sample) ... under Section II of PI967 / PI970: 1. Lithium battery handling label is NOT REQUIRED to be affixed on the package. 2. Part 1 (B) - Step 2 - "Information on a Separate Document" does not apply here. ...

G. Section II in Packing Instructions 967 and 970 states that "the lithium battery mark is not required on consignments of two packages or less where each package contains no more than four cells, or two batteries installed in equipment." What is the intent of this provision?

Also included within lithium metal are lithium alloy batteries. Lithium metal batteries are generally used to power devices such as watches, calculators, cameras, temperature data loggers, car key fobs and defibrillators. Note: Lithium metal batteries packed by themselves (not contained in or packed with equipment) (Packing

For the purposes of this guidance document and the IATA Dangerous Goods Regulations, power banks are to be classified as batteries and must be assigned to UN 3480, lithium ion batteries, ...

Regulations for Lithium Metal Batteries. Similar to lithium-ion batteries, lithium metal batteries also come with their set of transportation regulations, namely PI970 section II. These batteries are forbidden for transport as cargo on passenger aircraft. Thus, all packages prepared according to PI970 section II must bear a Cargo Aircraft Only ...

The words "Lithium metal batteries in compliance with Section II of PI970" Emergency information document must accompany the consignment Airline Requirements RLM- (Restricted Lithium metal) Required on NOTOC Full Acceptance check list required ELM - (Exempt Lithium metal) NOT required on NOTOC No check list required

The statement "Lithium metal batteries in compliance with Section II of PI970" must be shown on the AWB. (Different lithium battery types and/or packing instructions may be combined into a single statement) Not Required (Statement of Section II must not be shown on the AWB) UN3091 PI969 Section I Section II Labelling Marking ?Note 1? 1.

Compliant PI966, Section II Package "Lithium ion batteries, in compliance with Section II of PI966"on AWB. NOTE: On the first of the year (2023) ICAO will not permit 965 section II lithium ion batteries. DHL, FedEx and UPS are not accepting these now.

What is--or was--Section II? Packing Instructions PI 965 and PI 968 govern standalone lithium batteries. Section II of these Packing Instructions was created to allow packages containing one or two small batteries to be shipped in the same package by air with fewer restrictions, and by people without extensive Dangerous Goods training.. Specifically, ...

RU-04: UN 3480 Section IB, II of PI965, UN 3481 Section II of PI966 and PI967, UN 3090 Section IB, II of PI968 and UN 3091, Section II of PI969 and PI970 is accepted for carriage only with a ...
