In 2001, the Minnesota Legislature first enacted the Minnesota Renewable Energy Objective contained in Minnesota Statute section 216B.1691. As originally enacted, the Minnesota Renewable Energy Objective Statute required electric utilities to "make a good faith effort" to obtain 10 percent of their Minnesota retail
