Private equity investment in Europe's renewable energy sector has been on the rise in recent years, as GPs tap into growing demand for energy alternatives in the region. PitchBook data shows that in 2021, PE firms invested around EUR12.8 billion (about \$13 billion) in European renewable energy companies across 189 deals.
