

# Solar companies going out of business 2023

It is not rare for a solar company to go out of business and for its leases to be acquired by another firm; around 8,700 different companies installed at least one residential solar system between 2000 and 2016, according to the National Renewable Energy Laboratory.

However, 2024 has brought immense challenges, with higher interest rates, tighter financing, and adverse policy shifts in key states contributing to over 100 solar bankruptcies based on our industry data, a number unseen before in our almost 20 years in the solar sector.

After growing 31% in 2021 and 40% in 2022, residential solar will only grow by 13% in 2023 and then contract 12% in 2024, according to predictions from the research firm Wood Mackenzie. In part, that's due to higher interest rates than the industry has ever had to face.

Just a couple of months ago, in November 2023, the company announced that it would reduce the solar segment of its business, effectively cutting the number of its branches in half (38 to 16 branches).

SunPower, one of the largest and oldest solar companies in the United States, has taken its last dip after announcing bankruptcy and delisting from the Nasdaq Stock Exchange.

Diversification in services and business models within the industry enhances its adaptability. In conclusion, while the closure of several solar contractors in 2023 poses immediate challenges, the underlying strength and potential of the solar industry remain intact.

For active maintenance of future problems, you'll likely have to hire a new solar company to perform maintenance. Some companies "honor" their workmanship warranties even after they go out of business by hiring a company to handle their maintenance, but that doesn't mean it will be cost-free. At least 17 large solar companies, including SunPower, have gone out of business so far this year after more than 100 bankruptcies and closures in 2023 alone, according to SolarInsure, a solar ...
