As a ComEd or Ameren customer, you can get an upfront rebate if you install or already have a solar panel system and/or a battery storage system with a smart inverter. You'll earn \$300 for every kW of solar or kWh of energy storage you install. For a 5 kW solar panel system, you'd earn \$1,500.

In addition to solar incentives, Illinois also offers some great battery incentive programs to bring down the price of energy storage. As we said above, you can earn \$300/kWh of battery storage if you're a ComEd or Ameren customer and participate in the qualifying supply plans or Ameren's demand response program.
