In order to remain under NEM 2.0, you must submit a valid solar interconnection application before NEM 3.0 takes effect on April 13, 2023. The keys to grandfathering a solar system into NEM 2.0 are: Get solar quotes from reputable installers as soon as possible

As a result, the value of exporting excess solar power to the grid is lower in NEM 3.0 than under NEM 2.0. With net billing, California''s utilities use an adopted avoided cost calculator (ACC) to determine the value of your solar exports based on local energy demand. Using the ACC, the exact dollar amount of your credits is highly variable and ...

Update: NEM 3.0 took effect on April 15, 2023 and the window to grandfather new solar systems into NEM 2.0 is closed. If you submitted an interconnection agreement on or before April 14, 2023, your system can still be grandfathered into NEM 2.0 even if your utility reviews and approves your application after the submission deadline.

The proposed "monthly solar fees," also called the "solar tax," have been removed from the NEM 3.0 policy passed on 12/15/2022. While no solar tax will be associated with NEM 3.0, there will be charges that alter the dollar amount residential solar system owners can recover when they sell their excess energy back to the grid.
