Since Solar Victoria began rolling out government solar rebates and loans in 2018, more than 330,000 solar panel, battery and hot water systems have been installed in Victorian households. There is also the Solar for Rentals program, which offers eligible rental providers a rebate for the installation of solar panels (PV) on their property.
