

## Westjet lithium battery rules

Whether you can bring your drone in checked or carry-on baggage is determined by the size (Watt-hour rating) of the lithium-ion battery as follows: Where the lithium-ion battery exceeds 160 Wh, the device is prohibited in either checked or carry-on baggage. Where the lithium-ion battery exceeds 100 Wh but does not exceed 160 Wh, you may have ...

**Battery Capacity Limits:** Lithium-ion batteries installed in personal electronic devices can be carried without specific approval if they contain no more than 100 watt-hours (Wh) per battery. This ...

Spare lithium metal cells or battery packs with a maximum lithium metal content of 2 grams or less. If the cells or battery packs are removed from the device and carried on board, the device can remain in checked baggage. Lithium Ion Cell Battery Packs - with a rating of less than 100 Wh each. The following are permitted in carry-on baggage only\*:

WestJet doesn't allow hoverboards, airboards, airwheels, electric skateboards, balance wheels, mini-segways, battery assisted bikes, electric scooters, and any motorized luggage on flight. ... Furthermore, according to FAA PackSafe policies on lithium batteries, additional rules apply. Lithium batteries may overheat, leading to thermal ...

Please see checked baggage fees. Guests are allowed to check up to 4 bags. Please note: WestJet Encore baggage limit is only 3 bags. For flights to Kingston, Jamaica, the limit is 2 checked bags. Any checked bag exceeding the size or weight allowance is subject to all applicable oversized weight and size restrictions and fees.

What are the rules for bringing a trimmer on a plane? The rules for bringing a trimmer on a plane vary depending on the airline. However, in general, trimmers are allowed in carry-on luggage as long as they are not powered by lithium batteries. Trimmers that are powered by lithium batteries must be packed in checked luggage.

Consumer-sized spare lithium metal batteries (up to 2 grams of lithium per battery) may be carried. This includes all the non-rechargeable lithium metal batteries typically used in cameras. These include AA, AAA,

**In-Flight Usage:** Use devices powered by lithium batteries responsibly. Keep them in sleep mode or turned off when not in use. If you must use a device during the flight, keep it at a moderate temperature and avoid placing it under heavy items that could cause damage.

Must be properly identified with a lithium battery mark. I declare that the contents of this consignment have been properly prepared, and are packaged, marked, and labeled correctly, and are in all respects in proper condition for transport. All regulatory requirement have been met.

Lithium ion batteries exceeding a watt-hour (Wh) rating of 100 Wh but not exceeding 160 Wh may be carried in a device in either carry-on or checked baggage with air carrier approval.. Spare batteries: No more than 2 individually protected spare lithium ion batteries of 100-160 Wh are allowed per person in carry-on, with the approval of the air carrier.

Lithium batteries are considered dangerous goods. When it comes to travelling safely, always pack lithium batteries in your carry-on baggage. Make sure you follow the regulations set by your airline when packing for your next flight to reduce the risk of fire or explosion. Check with your airline for more information. The safety and comfort of our guests is a top priority and this rule will stand until further ...

Under international rules and regulations, Air Canada won't accept any small lithium battery-powered vehicles, such as e-scooters, hoverboards, gliders, etc., unless they fall into the category of mobility aids. This description is for a wheelchair or mobility device that does not have a protective housing for its lithium ion battery, i.e., the mobility aid does not provide adequate protection to the battery.
